Fitness Center Guidelines

- 1. HOURS OF OPERATION: Fitness Center is available during operational hours of the LPN. Hours may vary according to seasonal operational hour changes.
- 2. EQUIPMENT: The equipment is on a "first come, first serve" basis. Maximum time limit on any machine is 20 minutes.
- 3. EQUIPMENT: Pass holders and guests shall use the exercise equipment in accordance with written instructions by the manufacturers. Operational manuals are provided by the manufacturer and are located in the Fitness Center. Pass holders and guests are required to wipe perspiration off immediately after each use with cleaning materials provided by the facility. Pass holders and guests must report any equipment damage or needed repairs to guest services at 641-755-2080.
- 4. TELEVISION/AUDIO: Television is available for use while working out. Personal audio devices are not allowed unless with a headset.
- 5. ATTIRE: While using the fitness equipment pass holders and guests should wear appropriate exercise clothing. Shirts and appropriate footwear must be worn at all times.
- 6. FOOD AND BEVERAGES: Food and beverages will be allowed in the Fitness Center in a designated area. NO GLASS IS ALLOWED WITHIN THE FITNESS CENTER.
- 7. CONDUCT: Pass holders and guests are required to remain respectful of the rights of others while in the fitness room. Inappropriate comments, behavior, or conduct otherwise in violation of these guidelines, will not be tolerated.
- 8. PERSONAL BELONGINGS: All personal belongings are to be placed in a designated area within the Fitness Center. All personal belongings are to be removed and trash disposed of after use.
