Pool and Spa Guidelines

- 1. NO LIFEGUARD WILL BE ON DUTY: No one under the age of 13 may use the pool without the supervision of an adult.
- 2. CHECK-IN: Everyone must check-in prior to entering the pool to receive proper identification. Any individual found without proper identification will be asked to pay the appropriate fees or leave the pool.
- 3. ATTIRE: While using the pool, members and guests must wear appropriate swimsuits.
- 4. FOOD AND BEVERAGES: Food and beverages will be allowed in the area surrounding the pool, although no glass is allowed.
- 5. CONDUCT: Members and guests are required to remain respectful of the rights of others while in the pool. Inappropriate comments, behavior, or conduct in violation of these guidelines will not be tolerated.
- 6. PERSONAL BELONGINGS: All personal belongings must be removed, and trash disposed of after use.
- 7. EMERGENCY NOTIFICATION: In case of emergency, dial 911.

Pool Rules

- 1. All swimmers must shower before entering the pool.
- 2. No diving, horseplay, wall walking, or running.
- 3. No playing on or around ropes and ladders.
- 4. Any person having an infectious or contagious disease is prohibited from using the pool. No cuts or open blisters.
- 5. All children and non-swimmers must be accompanied by a responsible adult supervisor.
- 6. No food, drink, or glass objects allowed in the pool.
- 7. Management has the right to refuse admittance to, or eject from the premises, any persons failing to comply with any of the above health and safety regulations.

Spa Rules

- 1. Persons with a medical condition, including pregnancy, should not use the spa without first consulting with a physician.
- 2. Anyone with a contagious disease is prohibited from entering the spa.
- 3. Do not use the spa immediately following exercise or while under the influence of alcohol, narcotics, or other drugs.
- 4. Do not use the spa alone or without supervision.
- 5. Children must be accompanied by an adult.
- 6. Do not use the spa longer than ten minutes.
- 7. No diving or jumping into the spa.
- 8. Occupancy of the spa must not exceed posted rules.
